### **POLICE BURGLARY INVESTIGATION NETS FOUR ARRESTS**

In early April 2010, the Vacaville Police Department saw a sharp increase in the number of commercial burglaries in our city. Detectives from the Investigative Services Section (ISS) began an investigation into the series attempting to identify the responsables. This investigation culminated with the arrest of four suspects.

On May 5, 2010, 9:15 a.m., S-Adam Sexson, 39, of Vacaville was contacted during a vehicle stop in the 600 block of Marshall Road. S-Sexson, who is currently on probation, was arrested and booked into jail on the charges of burglary and possession of stolen property concerning ten (10) different criminal cases. S-Sexson was also charged with possession of burglary tools and violating the terms of his probation.

S-Bridget Banayat, 27, also of Vacaville was also contacted during this vehicle stop and found to be in possession of stolen property. S-Banayat was booked into jail and her probation was violated.

Search warrants were served at a residence in the 300 block of Buckeye Street and 4500 block of Shawn Lane in Vacaville in connection with this investigation. S-Darrin Gomez, 43, of Vacaville was contacted at the Shawn Lane address and found to be in possession of stolen property. S-Gomez was arrested and booked into Solano County Jail for these charges.

S-Roland Fitzgerald, 28, of Vacaville was also contacted at this location. S-Fitzgerald was arrested for possession of a controlled substance, possession of stolen property and violation of probation.

Detectives are continuing to work on these cases and follow up leads. Officers are contacting victims and identifying property. We are also returning the property to its rightful owners when possible. Anyone with information about these cases is asked to contact Detective Gary Anderson at (707) 449-5200.
