### SEX OFFENDER COMPLIANCE CHECKS LEADS TO ARREST OF SIX

On Wednesday, August 25, 2011, detectives from the Family Investigative Response Services Team (F.I.R.S.T.), Crime Suppression Team, Investigative Services Team, officers from the Solano County Probation Department, California Department of Corrections and Parole, and a detective from Vallejo Police Department assigned to the Northern California Computer Crimes Task Force conducted 33 individual 290 offender (sex offender) compliance checks throughout the city of Vacaville. The offenders were identified as being on probation or parole for crimes related to sexual assault and required to register as a sex offender.

The Vacaville Police Department routinely coordinates and conducts probation and parole checks on offenders identified to be on active probation or parole. During this compliance check operation, our agencies arrested the following individuals for various violations:

**Albert Vasquez**, 100 block Allison Court - Violation of Parole – no contact with other sex offenders

**Kenneth Ostrom**, 100 block Allison Court - Violation of Parole – no contact with other sex offenders

**Mark Speer**, 100 block of Aegean Way - Violation of Parole – under the influence of narcotics

**Gilbert Upton**, 200 block of Leisure Way - Violation of Parole – possession of alcohol

**Kelley Gallegos**, 100 block of Laurel St. - Violation of Probation – possession of alcohol

**Jesus DeLaRocha**, 200 block of Leisure Way - Violation of Parole – possession of pornography

We maintain a “zero-tolerance” policy while conducting these checks and encourage individuals to abide by the terms of their probation or parole.
