#### **VACAVILLE POLICE ARREST SUSPECT IN HIT-AND-RUN INCIDENT**

A suspect has been arrested in a hit-and-run incident that took place Tuesday evening that resulted in a 16-year-old Vacaville resident being hospitalized.

Vacaville police arrested S-Jason Hagberg, 41, at his Vacaville home without incident at 8:45 p.m. Wednesday evening.

S-Hagberg apparently saw a newspaper article regarding the hit-and-run incident, then called police and stated he was the driver of the vehicle. The investigating officer responded to S-Hagberg's home, where he was interviewed and subsequently arrested for felony hit-and-run. S-Hagberg was very cooperative during the investigation, and was booked into the Solano County Jail on \$15,000 bail.

**VACAVILLE POLICE SEEK SUSPECT IN HIT AND RUN INCIDENT**

Vacaville police are seeking a suspect who allegedly ran a curb and struck a pedestrian and then drove off Tuesday evening.

Police received a call at 6:21 p.m. Tuesday evening regarding a traffic collision involving a vehicle and a pedestrian in the 3500 block of Harbison Drive. Officers and paramedics arrived on the scene and learned that a 16-year-old male and Vacaville resident had been struck by a vehicle. The vehicle fled the scene prior to officers' arrival.

The victim was walking from the Ulatis Library toward the Morgan Park apartment complex on Harbison Drive, heading northbound on the east sidewalk. Witnesses told officers that a maroon SUV heading northbound on Harbison Drive drove onto the sidewalk and struck the victim. The victim was unconscious when emergency crews arrived and he was transported by ambulance to Kaiser Hospital in Vacaville for head trauma, abrasions, and pain to his arms and legs. The family stated the victim was listed in stable condition.

The SUV continued northbound on the sidewalk and struck a pole, and then some bushes, before entering back onto the roadway. The SUV was last seen northbound on Harbison Drive. Investigating officers located vehicle debris and fluids leading from the scene into the parking lot of the Target Store on Harbison Drive. Responding officers conducted an area check for the vehicle but were unable to locate it. An officer checked the surveillance video at Target, which showed the suspect vehicle entering the parking lot and parking immediately after the collision. The video also showed the suspect entering Target briefly and then leaving.

Vehicle parts found at the scene of the accident indicate they are from a maroon 2008 Toyota Sequoia. The attached flyer represents an approximate image and not the actual suspect vehicle. The photo of the suspect was taken from surveillance video.
